### RESERVATION OF ACCOMMODATION BY ASSOCIATE CLUB MEMBERS

#### Type of accommodation

The following accommodation may be available for reservation:

1	En suite with shower
2	En suite. No shower
3	Double bed and sink
4	Double bed and sink
5	4 bunks
6	4 bunks
7	Double bed and sink
Main bunkroom	10 bunks

Fresh bed linen is provided for rooms numbered 1, 2, 3, 4 and 7 within the room charge.

#### Charges and deposit

The current charges are set out on the Club's web site.

The deposit is £50.00 per person for each reservation period.

#### Requesting accommodation

If you are interested in making a reservation, please telephone the Club or send an email. You should read the following Terms and Conditions first and be ready to pay the deposit if you telephone. If you telephone, please email the office as soon as possible to confirm your request.

An email from the office will be sent to you to confirm whether or not the request has been accepted. Any acceptance is on the basis that the request was made subject to the following Terms and Conditions.

#### Terms and Conditions

1. A request for a reservation may be made by an individual, or by a person on behalf of another club, group or family. The person making the reservation is liable to pay the charges.
2. The reservation is only assured on an acceptance email being sent to the person requesting the reservation.

3. The deposit is payable on a request for a reservation being made or upon receiving the acceptance email.
4. The deposit will be held by the Midland Gliding Club on account of accommodation charges, membership and flying fees and all other charges, which the person requesting the reservation is liable to pay to the Club. No interest is payable on the deposit.
5. The deposit will be returned to the person who paid it within 14 days of the date of payment if the reservation is not accepted.
6. The balance of the deposit will be refunded to the person who paid it within 14 days of their departure in the event that the whole of the deposit was not been expended under paragraph 4.
7. The balance of accommodation charges, if any, is payable to the Club on or before the final date of departure.
8. A reservation may be cancelled at any time by the person who requested it, but the deposit will be forfeited if the cancellation is made within 30 days of the date of the intended arrival. The deposit will be returned to the person, who paid it within 14 days of any cancellation if the reservation is cancelled before the 30 day period begins.
9. The Club will do its best to provide the accommodation booked. However, the Club reserves the right to cancel a reservation in the event that accommodation ceases to be available whereupon the deposit will be returned to the person who paid it. The Club also reserves the right to vary the room booked if circumstances require this and will charge accordingly.
10. Individual bunks in the main bunk room may not be reserved and should be taken on a "first claimed" basis.
11. Individual bunks in rooms 5 and 6 may only be reserved if all four bunks are reserved for the same group.
12. All persons given accommodation become associate members of the Club from the date of the acceptance email and will be required to complete an application form for associate membership on arrival.
